**MINUTES OF AUGUST 2020 MEETING**

1. **CROESO / WELCOME**

3. **PARC/PARK**

Soniwyd bod yna Asesiad Risg wedi'u wneud ar gyfer trefnu ail-agor y Parc, Clerc i gysylltu â'r cwmni aswiriant Zurich. Clerc i anfon yr asesiad risg ymlaen i'r Cyngor Sir. Cwmni Lleol wedi dangos diddordeb yn gwneud y gwaith anghenrheidiol ym mis Medi. Cwmni ROSPA wedi gwneud arolwg ar y parc ym mis Mehefin yn ôl y drefn arferol.  
*Risk assessment had been completed on the Park of which the Clerk needs to forward a copy to the County Council for approval. Clerk to contact the Zurich Insurance to inform them that the park is ready for re-opening. Local company had been approached and were interested in carrying out the necessary maintenance works in the Park but would not be available until September. ROSPA had carried out their annual inspection on the park.*

*Meetings have been held regarding widening pavements to make passing places possible, earlier in the month, but nothing will be done for the time being.*
- 6.4 Soniwyd Cyng Catherine Hughes nad oedd angen cynnal cyfarfod blynyddol tan 2021 a cynnigwyd gan Cyng Alun Owen bod y Cadeirydd presennol yn sefyll yn y gadair tan y Cyfarfod Blynyddol nesaf, cytunwyd yn unfrydol.  
*Cllr Catherine Hughes announced that the AGM did not need to take place until 2021 and Cllr Alun Owen proposed that the exiting Chairman remained in post until the AGM in 2021, unanimously agreed.*
