Nodwyd y Cyngor Sir mewn cyfnod heriol iawn yn ariannol. Prif bwrpas y cyfarfod oedd i drafod y gyllideb â'r pwysau ac heriau cyllidebol sydd o'm</p>	

blaenau. Dywedwyd bod e'n bwysig dod â'r Cynghorau Tref a Chymuned gyda nhw ar y siwrne anodd.

Dywedodd Eifion Evans, Prif Weithredwr bod Cyngor Sir Ceredigion bod yr her sydd o'n blaenau'n frawychus. Mae Swyddogion wedi bod yn gweithio ar y gyllideb ar gyfer 2024/2025 ers yr haf pan ddaeth yn amlwg ein bod yn gwynebu arbedion sylweddol. Fe gyflwynwyd adroddiad cychwynnol i'r Cabinet canol Ionawr ac roedd hwn yn adlewyrchu'r sefyllfa y pryd hynny – mae pethau'n newid yn ddyddiol ar hyn o bryd. Roedd yr adroddiad hynny yn cynnig codiad yn Nhreth y Cyngor o 13.9% ond maent yn gweithio'n galed i gostwng hynny cyn bod y Cyngor yn gwneud penderfyniad ar 29 Chwefror 2024 ar gyllideb 2024/2025.

Nodwyd fod y sefyllfa i'r blynyddoedd sydd i ddod yn argoeli i fod yn waeth ac rydym eisoes yn meddwl ymlaen at yr heriau hynny.

Fe nodwyd yn ogystal bod y fformiwla sydd yn ein ariannu gan Llywodraeth Cymru (LIC) yn gweithio'n erbyn Awdurdodau gwledig fel Ceredigion. Maent yn gweithio'n galed i lobio bod y fformiwla yma'n newid ac ei fod yn tecach i bob Awdurdod yng Nghymru. Maent wedi trafod gydag Archwilio Cymru yn gofyn iddynt edrych ar tegwch y fformiwla. Hefyd, maent wedi herio'r Gweinidog Gyllid yn uniongyrchol a thrwy ein Aelod Senedd lleol, Elin Jones.

Nodwyd ei fod hi'n anodd i reoli'r gyllideb pan mae 'na annhegwch yn y system a'r gwirionedd yw fod trigolion Ceredigion yn colli allan.

Derbyniwyd cyflwyniad gan Duncan Hall, Pennaeth Cyllid ar cyllideb Cyngor Sir Ceredigion ar gyfer 2024/2025.

Yn unol â hyn, mae'r Cyngor Sir wedi gofyn i'r Cynghorau Tref a Chymuned edrych ar y posibilrwydd o gymryd drosodd rhai gwasanaethau ychwanegol yn lleol.

Meeting between Ceredigion County Council and the Town and Community Councils in Ceredigion

The Chair and the Clerk attend the meeting between Ceredigion County Council and the Town and Community Councils in Ceredigion at Canolfan Rheidol on January 30th. It was noted that the County Council are in a very difficult period financially. The main purpose of the meeting was to discuss the budget with the budgetary pressures and challenges ahead. It was said that it was important to bring Town and Community Councils with them on the difficult journey.

Eifion Evans, Chief Executive said Ceredigion County Council stated that the challenge ahead is daunting. Officers have been working on the budget for 2024/2025 since the summer when it became clear that they were winding up significant savings. An initial report was submitted to Cabinet mid January and this reflected the situation at that time – things are changing daily. That report proposed a rise in Council Tax of 13.9% but they are working hard to reduce that before the Council makes a decision on 29 February 2024 on the 2024/2025 budget.

It has been noted that the situation for the coming years promises to be worse and they are already thinking ahead of those challenges.

It was also noted that the formula funded by the Welsh Government (WG) works against rural Authorities such as Ceredigion. They are working hard to lobby that this formula changes and is fairer for all Authorities in Wales. They have discussed with Audit Wales asking them to look at the fairness of the formula. They have also challenged the Finance Minister directly and through our local Senedd Member, Elin Jones.

It was also noted that it is difficult to manage the budget when there are inequities in the system and the reality is that Ceredigion residents are missing out.

Duncan Hall, Head of Finance presented a presentation on Ceredigion County Councils' budget for 2024/2025.

In line with this, the County Council have asked Town and Community Council to look at the possibility of taken over some additional services locally.
